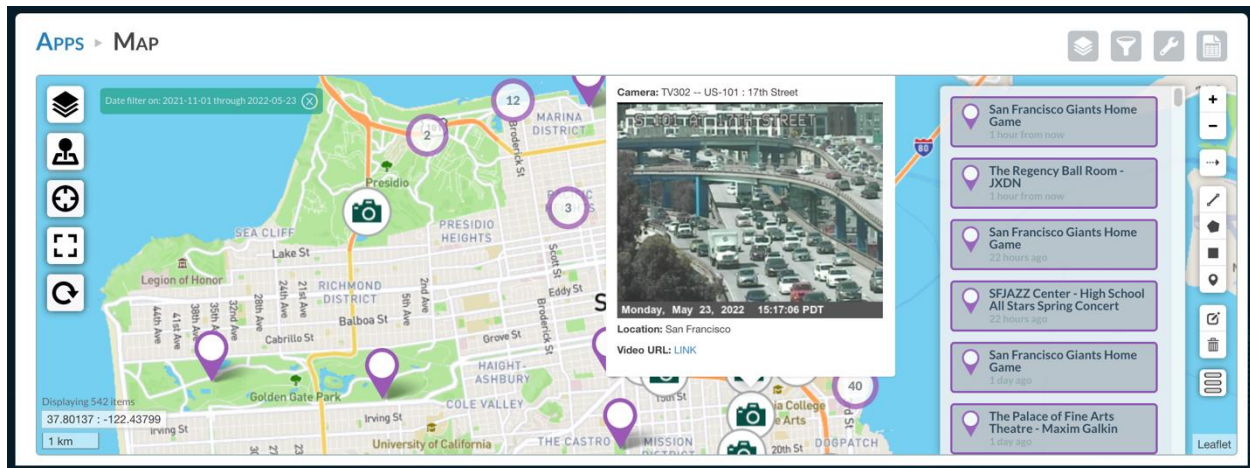

The California Common Operating Picture for Threat Awareness (Cal COP) is a cloud-based information-sharing environment available to all public safety agencies within California's eight Urban Areas Security Initiative (UASI) regions.

Purpose

Cal COP leverages local and regional risk management and critical infrastructure assessments — layered with real-time data on man-made and technological threats and natural hazards — to create a common threat awareness picture.

With Cal COP, users more rapidly and effectively understand California's emerging threat environment across public safety disciplines, agencies and jurisdictional boundaries. Access to the system is managed securely through user-based roles and responsibilities.



Core Use Cases

- Access/manage asset data
- Conduct assessments (school, Nonprofit Security Grant, fire, vulnerability)
- Collect/validate asset data for NCIPP data call
- Assess, measure, and prioritize risks
- Strategic and operational planning
- Mobile field reporting (damage, field intel)
- Collect/validate event data for DHS Special Events Data Call
- Conduct damage assessments
- Incident management (notification and alerting, automated incident creation)
- Data visualization (map layer imports, CAD, AVL, 311, SARs, etc.)
